**This Alert updates & replaces the one issued 12/03/2009. All previous Alerts on this subject should be completely destroyed as they are no longer valid.**

Subject was a volunteer at the Bureau of Animal Regulation and Care (BARC) at 2700 Evella until dismissed from her volunteer status for insubordination toward BARC management on Thursday, December 03, 2009. At that time Interim Bureau Chief Gerry Fusco ordered that this subject not be allowed on BARC property. The access status is amended by this Security Alert.

Please be aware that this subject may still be in possession of her City of Houston Volunteer ID badge displaying the photo below..

**SECURITY RESPONSE**

If this subject comes to the BARC facility she should be handled as any other private citizen would be. She may be allowed to enter any area where the general public is permitted. She should not be allowed to enter any area that is restricted and not open to the public.

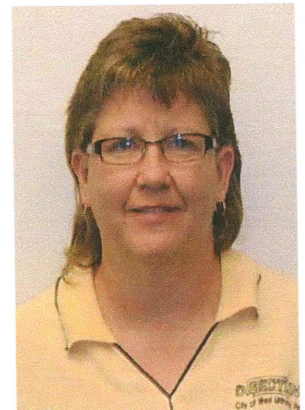
If subject is found to be in possession of her City of Houston Volunteer ID badge, the badge should be confiscated, as it is the property of the Security Management Division of General Services Department as outlined in Executive Order 1-37. The badge should be sent directly to the Security Management Division. It is a violation of ARTICLE XII, Sec. 2-417, of the Houston Code of Ordinances for her to attempt to use her ID badge as it has been deactivated.
